#### MEDICAL MISTAKES ARE SELDOM ACKNOWLEDGED

Most people don't realize a common cause of Cerebral Palsy is from medical mistakes during pregnancy or childbirth. Hospitals, physicians and other healthcare workers seldom point out their mistakes to families of injured children. It's also not uncommon for medical professionals to allow families to feel as if the family is responsible for the birth injury or to create the impression the injury was "An Act of God."

Even well meaning healthcare workers are often not knowledgeable on where to send CP families for help. We have even seen cases where families of CP children were allowed to take their child home from the hospital with the only instruction being to "Learn CPR." CP families often do not know where to turn to seek the resources they need to help their children - so the children often do not receive the care they deserve. #### THREE STEP NO COST PROCESS

- 3. With the permission of the child's parents or guardians we then represent the child through each step of the process.
